


Background

- The lowest responsive and responsible bid was received by Presidio Networked Solutions, LLC in the amount of \$516,824.43.

This 3-year contract is funded with local capital funds.

WHEREAS, the Authority's Department of Information Technology has identified the need for the Procurement of VMware vSphere Foundation Maintenance and Support Services, Invitation for Bids Number B50525; and

WHEREAS, on May 28, 2024, the Metropolitan Atlanta Rapid Transit Authority duly sent Notice of the Invitation for Bids to potential Bidders; and

Financial / Procurement / DBE Considerations

Financial Considerations

- This 5-year contract is funded with 100% local operating funds.
- This modification would increase the contract value by \$12,514,079 from \$22,938,274 to \$35,452,353
- Internal audit found the price to be fair and reasonable.

DBE Considerations

The Office of Diversity and Inclusion did not assign a DBE goal for this single-source procurement.

The Department of Technology is seeking your approval authorizing the modification of the existing contract for maintenance and support of Oracle Database, ERP, and ID Management Licenses P27978, with Oracle America, Inc. by \$12,514,079 to a maximum contract value of \$35,452,353.

WHEREAS, on December 02, 2012 the General Manager entered into a Contract with Oracle America, Inc. for Maintenance and Support for Oracle Database, ERP and ID Management Licenses, Request for Proposals RFP 27978; and

WHEREAS, on April 14, 2015 MARTA's Board of Directors of the Metropolitan Atlanta Rapid Transit Authority authorized the General Manager/CEO or his delegate to increase the contractual authorization to add additional funds for Maintenance and Support for Oracle Database, ERP and ID Management Licenses, Request for Proposals P27978 in the amount of \$1,277,024.50; and

WHEREAS, on December 15, 2016 the General Manager/CEO's contingency of \$189,851.20 was requested and utilized; and

WHEREAS, on April 13, 2017 MARTA's Board of Directors of the Metropolitan Atlanta Rapid Transit Authority authorized the General Manager/CEO or his delegate to increase the contractual authorization to add additional funds for Maintenance and Support for Oracle Database, ERP and ID Management Licenses, Request for Proposals P27978 in the amount of \$1,316,623.05; and

WHEREAS, on April 12, 2018 MARTA's Board of Directors of the Metropolitan Atlanta Rapid Transit Authority authorized the General Manager/CEO or his delegate to increase the contractual authorization to add additional funds for Maintenance and Support for Oracle Database, ERP and ID Management Licenses, Request for Proposals P27978 in the amount of \$684,543.30; and

WHEREAS, on October 6, 2018 MARTA's Board of Directors of the Metropolitan Atlanta Rapid Transit Authority authorized the General Manager/CEO or his delegate to extend the contract term and increase the contractual authorization to add additional funds for Maintenance and Support for Oracle Database, ERP and ID Management Licenses, Request for Proposals P27978 in the amount of \$7,704,727.00; and

WHEREAS, on August 12, 2021 MARTA's Board of Directors of the Metropolitan Atlanta Rapid Transit Authority authorized the General Manager/CEO or his delegate to increase the contractual authorization to add additional funds for Maintenance and Support for Oracle Database, ERP and ID Management Licenses, Request for Proposals P27978 in the amount of \$7,219,680.00; and

WHEREAS, on December 13, 2021 the General Manager/CEO's contingency of \$194,512.00 was requested and utilized; and

WHEREAS, on May 9, 2024 MARTA's Board of Directors of the Metropolitan Atlanta Rapid Transit Authority authorized the General Manager/CEO or his delegate to

increase the contractual authorization to add additional funds for Maintenance and Support for Oracle Database, ERP and ID Management Licenses, Request for Proposals P27978 in the amount of \$1,831,313.17; and

WHEREAS, MARTA staff has determined that it is in the best interest of the Authority to extend the contract term and increase the contract value to provide for known changes and additions to the contract; and

WHEREAS, all contractual changes and additions for this modification will follow the Authority's procurement policies and guidelines; and

WHEREAS, the Department of Internal Audit conducted a price analysis and determined the price to be fair and reasonable; and

RESOLVED THEREFORE, by the Board of Directors of the Metropolitan Atlanta Rapid Transit Authority that the General Manager/CEO or his delegate be, and hereby is, authorized to extend the contract term and increase the authorization for Contract No. P27978 Maintenance and Support for Oracle Database, ERP and ID Management Licenses from \$22,938,274.22 to \$35,452,353.22.



"Cyber" Liability Coverage Basics

- Provides both first party and thirdparty coverage
- First party coverage is for the policy holder
- Covered costs: Credit monitoring services for customers; PR and reputation management campaigns
- Third party coverage is for legal liability of Authority to another entity or individual
- Covered costs: Regulatory defense costs, PCI fines and penalties





Cyber Insurance Market Snapshot

Claims and Risk Environment

- Geopolitical tensions driving market uncertainty
- Aggregation exposure and supply chain risk continue to be top of mind
- Ransomware severity and sophistication continues; data encryption and business interruption most impactful
- Privacy claims & regulatory claims frequency rising in connection with broader privacy regulations & rights

Pricing

Rates stabilizing & more capacity is now available for clients with favorable cybersecurity controls



2024-25 Policy Renewal

Renewal Strategy


- Start Early- Met with MARSH and MARTA CISO and IT Teams in May
- CISO and IT Teams jointly completed the MARSH Cyber Security self assessment tool
- Results of assessment provide broker with actionable information to take into marketplace





2024-2025 Policy Renewal

- Increase limits from \$ 10M to \$20M
- Maintain \$1 million dollar self-insured retention
- Annual cost = \$ 775,000 (not to exceed)
- Increase in cost for additional limits \$ 207,540

RESOLUTION AUTHORIZING RENEWAL OF PRIVACY AND NETWORK SECURITY LIABILITY (CYBER) INSURANCE COVERAGE

WHEREAS, MARTA has privacy and network security liability (cyber) insurance coverage with limits of \$ 10 million dollars with an expiration date of October 1, 2024, and

WHEREAS, negotiations by MARSH have resulted in proposals for replacing this policy, effective October 1, 2024 for one-year, to October 1, 2025, and

WHEREAS, such privacy and network security liability (cyber) insurance coverage is available for a one-year period and includes limits of \$ 20 million dollars excess of a self-insured retention of \$ 1 million dollars at a total not to exceed cost of \$775,000, and

RESOLVED THEREFORE, that the General Manager/CEO or his designee is hereby authorized and directed to affect the placement of privacy and network security liability (cyber) insurance coverage, effective October 1, 2024 to October 1, 2025 at a total not to exceed cost of \$775,000.




Ad Policy Update & Revenue Impact



- Stopped Restricted Ad sales in late 2023: Legal, Bail Bonds, Alcohol, and Predatory Lenders
- Declined ~\$2M in deals
- 2024 revenue forecast cut to \$6.5-\$7M from \$8.5-\$9M.
- 2025 outlook declines without Restricted Ad revenue.
 - Revenue forecast \$4.7-\$5M

WHEREAS, on December 7, 2021, the General Manager entered into a Contract with Intersection Media, LLC., for Transit and Digital Advertising Services, Request for Proposals P48265; and

WHEREAS, MARTA staff has determined that it is in the best interest of the Authority to adjust the contract revenue shares to provide for known changes and additions to the contract; and

WHEREAS, all contractual changes and additions for this modification will follow the Authority's procurement policies and guidelines; and

RESOLVED THEREFORE, by the Board of Directors of the Metropolitan Atlanta Rapid Transit Authority that the General Manager/CEO or his delegate be, and hereby is, authorized to adjust the authorized revenue shares for Contract No. P48265 Transit and Digital Advertising Services for year three (3) and each subsequent year from 70% revenue share of advertising for transit buses and 50% for transit rails to 30% revenue shares for the first \$5,000,000 and 70% revenue shares for all Net Advertising Revenue over \$5,000,000, for transit buses and rails combined.
